Board Message

A school budget is a planning document. Although limited by state statutes and regulations, it demonstrates what the District values and plans to do. As with any plan, it must be flexible when events which cannot be reasonably expected occur.

On Monday, April 27, 2015, the Allamuchy Township Board of Education will consider for adoption the proposed budget and tax levy for the 2015–2016 school year. The Board adopted a preliminary budget for review by the Department of Education on March 23, 2015. The proposed budget, when it is approved by the Department of Education, will be published in the *Express Times* and also available for examination in the Board of Education offices.

The process of developing the 2015–2016 budget began in October 2014. The Board of Education, through the various committees, gives the administration recommendations grounded in policy for the development of the budget. Typically these policy recommendations would focus on considerations such as programming, facilities and personnel. As the process advances, discussions on the interplay of the policy recommendations with fiscal considerations such as high school tuition, contractual obligations and fixed costs and how these matters affect the tax levy lead to regular revisions of the draft budget. In mid-March, the budget process comes to a culmination with the release from the State of the State aid figures. The Board adopts a preliminary budget for State Department of Education review. After a public hearing, the last step is the adoption of the budget. Throughout the process, including at the final hearing, the Board is able to revise the budget.

Even after the adoption of the budget and the striking of the tax levy, line items within the budget, but not the tax levy, are subject to modification with approval from the Department of Education. The two most significant limitations in the budget process are the 2% tax levy cap and flat or diminished state aid. Fortunately, in previous years, the District's budget and tax levy did not meet the 2% limit, allowing the District to utilize the underused portion known as banked cap. This year's budget goes to the full 2% tax levy cap plus utilizes available banked cap. Approximately 85% of the preliminary budget is comprised of contractual or otherwise fixed expenses. The administration toiled meticulously over the revenue and expense line items to reach the proposed budget. Many of the most important operative considerations are:

- All the current educational programming in the District will be continued, including music, art, full-day kindergarten and a robust co-curricular program;
- The budget anticipates the benefits of a shared chief school administrator;
- Due to enrollment and an increased tuition rate, high school tuition to Hackettstown increased by over \$500,000, which is more than can be raised by the allowable tax levy increase;
- The tuition to Hackettstown is being managed by averaging payments over several years to account for the fluctuations in the number of Allamuchy students attending Hackettstown High School. We are grateful for the cooperative relationship we have with our partner district that allows us to negotiate this favorable budget scenario;
- Health insurance costs increased by approximately 8%.
- The administration and the Board investigated, but rejected as resulting in an increase of costs, privatizing some aspects of operations including transportation and custodial services;
- Some staffing is being reorganized or restructured to economize;

- Certificated staff will experience small attrition through retirement or changing needs of our current students;
- Known special education costs have been incorporated into the proposed budget as well as a contingency for unexpected special education costs. Future utility expense savings will be realized as a result of an agreement to construct a solar array on Board property;
- Student population is at an all-time high; class sizes will be larger than those of recent years but still within educationally sound levels

Moreover, the Board expects that the debt service portion of the tax levy will also be reduced as a result of the recent initiative to capitalize on low interest rates with a refinance of outstanding bonds. That refinance is expected to result in savings of approximately \$327,000 over the remaining term of the current bond issue for a typical tax levy savings of approximately \$18,000 per year.

On the revenue side of the budget, the District relies on the tax levy, federal funding of certain programs, state aid and other revenues. The federal funding is tied to certain programs such as Title I and IDEA. Allamuchy does not receive a significant amount of such funding. The District, through a shared commitment to be innovative, has increased revenues in areas such as transportation and out-of-district tuitions received. The District realized no increase in state aid for the third straight year. When measured against state aid levels from 2011, the District is realizing in excess of \$170,000 less in this category of revenues plus the impact of inflation and costs over time. We are able to keep our level of staffing and programming only through the dedicated hard work of our entire staff and the willingness of the Board to examine alternatives in raising revenues and reducing expenses.

It is important not to forget that the overall success of our efforts is measured by the success of our students after they leave Allamuchy Township School. The vast majority of our graduates go to some of the best colleges and universities in our country. They do so after four successful years at Hackettstown, Pope John, Blair Academy and other notable high schools. We acknowledge that the success of our students rests on the good efforts of our Allamuchy residents, parents, administration and staff as well as the students themselves.



Vegetable, herb or flower?

Mr. Lohse's 4th grade science class students were left guessing what their mystery seed would grow up to be during a recent greenhouse enrichment activity. After trying their hand at seed germination using a baggie and coffee filter, the students potted up their seedlings using an assortment of recycled yogurt, cereal, pudding and applesauce containers.

In mid-May, the identity of each child's seed will be revealed. At that point, students will label and transfer their plant in the school courtyard garden. Next September, as 5th graders, they will have the opportunity to share in the harvest of their individual plant.

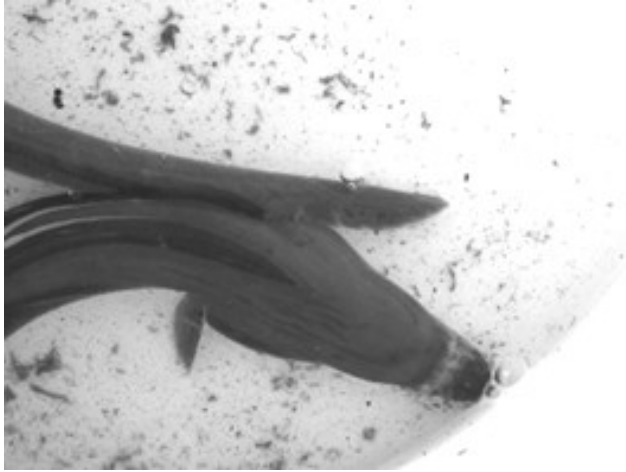
Dove Environmental Education provides hands-on, interactive programming that teaches children what they can do to help the environment by protecting wildlife and habitats. Through these special programs, children understand how litter harms wildlife and how they can take positive action to make a difference. Dove Environmental Education received special recognition from the Warren County Department of Economic Development, the Board of Chosen Freeholders, and the NJ Department of tourism for award winning programs for all ages. Diana Dove, an Environmental Educator since 1975, has been recognized for her work with young children. She is the recipient of the 2011 New Jersey Clean Communities "Excellence in Education" award and the Alliance of NJ Environmental Education "Environmental Educator of the Year" award.

Throughout the program, the children learned many valuable lessons about animal survival needs and how they can take action to help keep our environment clean and healthy. Mr. and Mrs. Dove gave a very fun and informative presentation on animal habitats and the importance of recycling and keeping the environment clean to protect these habitats. The children participated in several hands-on discovery centers that allowed the children to experience nature up

close. They completed a field guide challenge by researching facts related to specific animals and their habitats while viewing taxidermy animals and natural artifacts. A favorite activity involved making models of animal tracks in clay including beaver, bear, and bobcat tracks. The children couldn't wait to take their models home!

Most importantly, the Dove Environmental Education program motivated the children, natural animal lovers, to take action in our community and focus more of their attention on recycling and keeping our community clean. We would like to thank the Allamuchy Environmental Commission for providing the funding for this wonderful educational opportunity for our students.





SURPRISE GUEST

I learned about several unique educational programs being offered at Rutherford Hall. One was for water quality testing: students tested the dissolved oxygen, PH, Turbidity and temperature, being conducted by Nancy Baglio. The second course was the macro-invertebrate Study, being conducted by Deb DeAngelis. I was very interested in both these courses! As a matter of fact, I will be conducting these same basic tests and investigations as a member of River Watchers, a program sponsored by the Musconetcong Watershed Association. The River Watcher Program monitors the Musconetcong River at various sites, four times a year! The information collected is then forwarded to NJ DEP and entered into their database.

I visited the classes at Rutherford Hall, where I meet Deb DeAngelis. I am very familiar with the great work and exciting activities created and conducted by Deb and the school, through my position as Director Open Space and through The Allamuchy Township Environmental Commission which has often co-sponsored her work! Deb then gave this description of the programs:

In November we filled leaf/onion sacks with leaves and a couple of rocks to help keep them under the water. These were placed in the running stream portion of Allamuchy Pond and two were placed at the stream over at the ATS school. A total of 10 sacs were put into the water. The purpose was to collect a sample of macro's. These test sacks were actually in the water longer than usual, which worked to our advantage giving us a nice sampling of macro's.

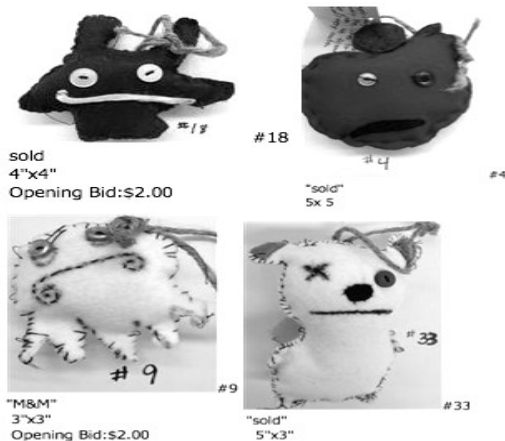
Deb continued,

Macro-invertebrates as well as Water Quality testing tell us the water quality and the diversity of aquatic life. Macro-invertebrates is a study of biological organisms and their responses that allow us to determine the environmental conditions of the water. They are good indicators of stream quality. I spent several weeks teaching the sixth graders about water quality and the macro-invertebrates prior to coming over to Rutherford Hall for this investigative hands-on portion of the lesson.

During my visit with the classes, there was a loud commotion, A SURPRISE GUEST APPEARED!! This visit/appearance, just capped off an already special day! I sent photos to some experts including Royal Nadeau, Ph.D. a member of the Environmental Commission. He advised that we had found a young American Eel. It is one of the few catadromous fishes in the world! That means that the species reproduces in the ocean and migrates to fresh water to grow and mature.

What a great, wonderful learning experience for our students and Deb advised that there are plans to make this course at Rutherford Hall available to other schools!
