My hope is this letter finds you well and you are looking forward to spring. I would like to thank all the parents and the community for their patience with us while we worked on coordinating the busing for the district to allow for the least amount of disruption to you as a parent, the school and most importantly the students. Our goal is to provide a mechanism to allow us to ensure students are transported to and from school safely and in a timely manner.

With that said, we believe that we have developed a solution that would allow us to solve the challenges we currently have and allow the solution to carry us through the end of the school year. To understand the changes I have shaded the Routes that are being affected. Students from Route #1 Second Run will be placed on the following Routes; Route #2 Second Run, Route #4 and Route #5. In addition, Students that are at the Poplar Stop on Route #3 will be placed on Route #4. (Please see the chart below as a graphic.)



We have notified all those that will be affected by the change and have placed the Route Stops with Times on the Website should you need that information.

When those adjustments are made, we will continue to communicate those changes when necessary through the instant alert system. In addition, we will make every effort to communicate those changes in a timely fashion to allow for appropriate planning.
