Board Message

One of the primary functions of the Board of Education and each member of the Board is to serve as the conduit for information between the school district and the community. That conduit delivers a dialogue, not a monologue. So, here follows information on matters of importance which have been the focus of discussion by the Board of Education at recent meetings.

Fiscal Matters. Since the late summer, the district has encountered unexpected fiscal challenges. Since the Board adopted the 2014-2015 budget in April 2014, a budget that was reviewed by the NJ Department of Education, circumstances have changed significantly. Two items are especially operative in creating the challenges we now face. At the time, the district was finalizing an agreement with a nearby school district to share chief school administrator services. We were going to share Dr. Cohen. Such an arrangement allowed us to budget for that line item at one-half the total cost. We did not anticipate that Dr. Cohen would resign soon after we adopted the budget. Normally that would not present a difficulty. However, in the second half of August, new enrollments in the district required us to find approximately \$250,000 which we could not have anticipated for special education costs for students with Individualized Education Plans mandated under federal law. This development has created a challenge. Another factor is our growth in student population, and concomitantly tuition, at Hackettstown High School. The effects of these two fiscal issues are felt throughout the district. As a result, class sizes in some grades and some special subjects are larger than what we have typically had and certainly than what we prefer. We could not hire additional teaching staff to address this issue. The status of the chief school administrator position remains unresolved in part because of the fiscal situation. We have addressed the Hackettstown tuition matter with an agreement to phase in our tuition increase over several years. But the fiscal effects of the August enrollments will continue for the foreseeable future. These challenges are exacerbated by the increasingly constricting effect of the tax levy cap. Accordingly, the Board must explore all viable options, including shared services. On the positive side, Rutherfurd Hall produced a modest positive net revenue for the 2013-2014 fiscal year, and we anticipate that it will grow for this current year. The district continues to explore other creative methods either to trim expendures or to generate income. For instance, the Board has just entered into an agreement for the construction of a solar energy system that will significantly reduce the cost of energy for the Allamuchy Township School beginning in 2016. We are confident that in both the short term and the long term, the administration will continue to propose and implement educationally sound and fiscally responsible solutions.

Chief School Administrator Position. When Dr. Cohen submitted his resignation, the Board resolved to fill the vacancy by December 31. The Board crafted a plan to advertise for the position, to conduct a series of public discussion sessions with stakeholders, to interview qualified candidates and then to retain the best qualified and most suitable candidate by the deadline. The Board proceeded on that plan, getting to the point of interviewing five qualified candidates. At that time, the effects of the unexpected special education costs began to manifest themselves. The Board suspended the search in order to consider the fiscal challenges and their effect on the search. In the meantime, the Board has extended the contract with the interim CSA, Dr. Frederiks, who served as our CSA for seven years from 2005 to 2012. More fully informed decisions can be made as the Board and the district proceed through the budget development process. The goal to have a long term resolution of the CSA vacancy as soon as is practicable still remains. (continued on page 2)

District Goals. The Board of Education, in consultation with the administration, adopts goals annually. Every year, one or more of the goals are the product of analysis of the testing data for the district. Board and administrative decisions occur in the context of these annual goals. This year's goals, which were adopted on November 4, 2014, are: 1) to increase the use and student understanding of informational text across the curriculum in grades 2-8; 2) to increase the use and student understanding of numbers operations/ fractions in grades 3-5; 3) to increase average daily student attendance in school; 4) to create a focus on district plant needs at Allamuchy Township School, Mountain Villa School and Rutherfurd Hall; 5) to develop and adopt policy related to the total operations of Rutherfurd Hall; and 6) to develop and deliver two rounds of pilot field-based educational experiences, based on student competencies listed in the Core Curriculum Content Standards (CCCS), delivered on the grounds of Rutherfurd Hall and the larger Allamuchy Farms campus and to package these trips and market them to local Warren/Sussex and Morris County school districts. Technology. The Board of Education adopts periodically a technology plan for the district. The plan is formulated by the administration with policy based input from the Board of Education. Our technology plan addresses the identified technological needs of the district. One of the most pressing technology concerns was the district's preparedness for PARCC testing. Accordingly, the plan specifically targeted necessary technological infrastructure improvements and bandwidth growth. With the assistance of the Allamuchy Township Education Foundation we were able to purchase additional Chromebooks. As a result, we are rather well prepared for the State tests as was demonstrated during Allamuchy's participation in the field test last spring. Aside from testing, the district utilizes technology to supplement learning. With the assistance of the PTO the district has been able to acquire tablets to assist the special education teachers. The technology plan and the progress of the district in implementing that plan are the object of at least annual reflection. The plan is revised periodically to take into account changing circumstances. Technology is important in the education of our children, but it is just a supplemental tool in their development.

PARCC. <u>P</u>artnership for <u>A</u>ssessment of <u>R</u>eadiness for <u>C</u>ollege and <u>C</u>areers. Elsewhere in the *Board Report* is information about the administration of the PARCC in Allamuchy and what it means for our children. This is the State's replacement for the NJ ASK tests. The assessments must be taken on computers. There are two administrations, a formative assessment in March and a summative assessment in late April and early May. It will displace a significant amount of instructional time. Students in grades 2 through 8 will take the assessment. The PARCC assessments are the source of a great deal of controversy including: the advisability of testing elementary school students as early as 2^{nd} grade for college and career readiness, the loss of significant amount of instructional time, the emphasis on non-fiction reading, the relationship of the tests to the controversial Core Curriculum Content Standards, the inclusion of test scores as an element of teacher evaluation and the resulting teaching to the test. The district will be administering these tests. We expect our students will do well overall on them. If there is information and make systemic and programmatic adjustments accordingly. <u>The Partnership for Assessment of Readiness for College and Careers (PARCC)</u> represents a fundamental shift in how we think about testing, state to state. PARCC is based on the core belief that assessment should not be a process to penalize educators and districts, but rather a tool for enhancing teaching and learning. The PARCC assessments in English Language Arts (ELA/ Literacy) and Mathematics are carefully crafted to give teachers, schools, students and parents better and more useful information on how we're preparing our kids for careers and college — and life. Looking ahead, PARCC will be:

A useful tool for teachers. Computer-based assessments deliver real-time information on student knowledge that teachers can use to help inform instruction. No longer will teachers, students and families be waiting for results that don't arrive until it's too late to use the information to help kids.

More engaging for students. Times have changed. In the digital age, students process and relate information differently than they did in the past. It's time to retire the old pencil-and-paper bubble tests and replace them with online tools that will accelerate and enhance student learning.

An economic opportunity for states. For the first time, states and local communities will know how their students stack up against their peers in neighboring states and cities. This is a crucial shift that gives educators, policymakers and community leaders better information on how to plan for and develop the workforce of the future.

Testing Windows

Performance-Based Assessment (PBA) March 2 – March 22, 2015 (75%)

ELA - writing effectively when analyzing text.

Math - applying skills, concepts, and understandings to solve multi-step problems requiring abstract reasoning, precision, perseverance, and strategic use of tools.

End-of-Year Assessment (EOY) April 22 – May 22, 2015 (90%)

ELA - reading comprehension.

Math - demonstrate further conceptual understanding of the Major Content and Additional and Supporting Content of the grade/course.
